I came across a listing for an iPhone 14 Pro on Facebook Marketplace at a price significantly lower than market value. I contacted the seller through Facebook Messenger.

The seller asked me to continue the conversation on WhatsApp. During the conversation, he created urgency and told me that multiple buyers were interested and that I needed to confirm immediately.

He requested an advance payment to secure the product. Trusting his claims, I transferred NPR 25,000 to the provided account.

After receiving the payment, he initially said he would dispatch the product the next day. However, shortly after, he stopped responding to my messages and eventually blocked me on both WhatsApp and Facebook.

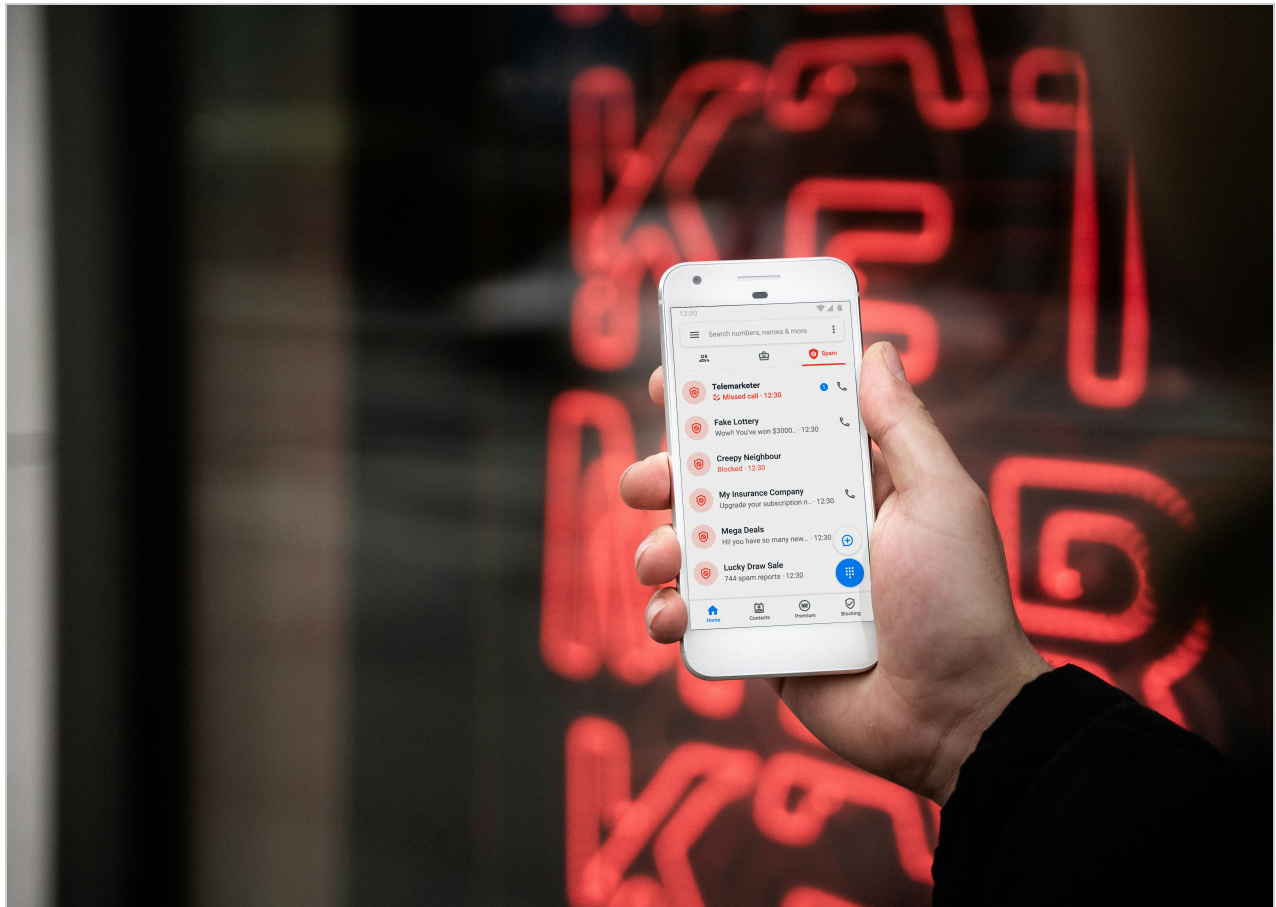
